School Annual Education Report (AER) 2020/2021

Dear Parents and Community Members:

We are pleased to present you with the Annual Education Report (AER) which provides key information on the 2020-2021 educational progress for Kingsley High School. The AER addresses the complex reporting information required by federal and state laws. The school's report contains information about student assessment, accountability, and teacher quality. For the 2020-21 school year, schools were identified using definitions and labels as required in the Every Student Succeeds Act (ESSA). A Targeted Support and Improvement (TSI) school is one that has at least one underperforming student subgroup. An Additional Targeted Support (ATS) school is one that has a student subgroup performing at the same level as the lowest 5% of all schools in the state. A Comprehensive Support and Improvement (CSI) school is one whose performance is in the lowest 5% of all schools in the state or has a graduation rate at or below 67%. Some schools are not identified with any of these labels. In these cases, no label is given. Kingsley High School is one of the schools that has not been labeled for targeted school improvement.

Kingsley High School continues to work hard to improve the courses of study that we offer all of our students. Increased student achievement, and gaps in achievement are focal points when building academic interventions. Extended Learning Opportunity, individualized tutoring, and other interventions and programs strive to increase and bridge the achievement levels of all students.

Status of the School Improvement Plan

Kingsley High School is in full compliance with the Michigan Department of Education school improvement plan model and that of North Central Accreditation (NCA) to develop and implement the school improvement plan. This model is provided through Advance Ed, an online tool that allows schools to develop goals and strategies to address areas that are in need of enhancement or improvement. Kingsley High School currently has four school improvement goals that are focused on the improvement of student achievement in the areas of math, science, social studies, and language arts.

Description of Core Curriculum and Implementation

This process was done with the cooperation and work of the Professional Learning Community (PLC) teams here at Kingsley High School. Once those learning goals were developed for all coursework, those learning goals were then linked to the High School Standards for the State of Michigan.
